SECTION 4 – FIRST AID MEASURES

Handling: Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of dust.

Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use – check regularly for spills.
